**GOVERNMENT’S MOTION REQUESTING AN ORDER TO SHOW CAUSE  
AS TO WHY DEFENDANT’S BOND SHOULD NOT BE REVOKED**

On January 29, 2021, the Court issued an Order enjoining the parties “. . . from divulging, talking to, or discussing with, the press, media and public, including without limitation, through social networks, any information other than that entered without restriction on the docket or disclosed in open court, relating to the facts of the captioned case ....” Dkt. No. 10. On February 12, 2021, the Court issued a protective Order barring actions by the Defendant disclose, directly or indirectly, Discovery Material or the substance thereof to anyone, including the media (excepting any disclosures that may occur during public proceedings at a hearing, trial, or appeal in connection with this matter) . . . .” Dkt. No. 20. For the second time, Defendant has openly violated both of these Orders. The Government hereby moves for an order to show cause why the defendant should not be held in contempt of court for his willful conduct and moves for a revocation of the defendant’s bond and remand to the custody of the United States Marshals Service.

## DISCUSSION

On January 27, 2021, Sixto Jorge Diaz Colon was arrested pursuant to an Indictment charging him with violations of Title 18, United States Code, Sections 2, 875(d), 1519, and 1951. The charges in the Indictment reference events taking place in Puerto Rico that garnered significant media exposure during the summer of 2019. Some of the evidence that will be introduced in this case at trial concern the attempted manipulation of public opinion through the use of media influencing. In order to protect the rights of all parties, including the rights of the Defendant, and to preserve the integrity of all future proceedings, the Government requested that the Court issue a Gag Order. *See* Dkt. No. 8 (Gov't Mot. to Restrict).

Without objection from the defense, on January 29, 2021, the Court issued the requested Order. *See* Dkt. No. 10. The Order read in pertinent part:

As a cautionary measure to protect the rights of all parties and preserve the integrity of all future proceedings, the following individuals are hereby enjoined from divulging, talking to, or discussing with, the press, media and public, including without limitation, through social networks, any information other than that entered without restriction on the docket or disclosed in open court, relating to the facts of the captioned case ...

The parties may seek relief under seal for good cause shown. This Order should not be interpreted to preclude government or defense investigative efforts and is not intended to prevent the press and media to report, opine, and inform about the case. Nor will it operate to automatically close proceedings or block access to public portions of the record.

This Order will be in full force from the date of its execution until the conclusion of trial. Violations to the terms of this Order will be met with economic sanctions, including but not limited to contempt of a clear court order.

On February 12, 2021, the Court issued a protective order applicable to discoverable material. Dkt. No. 20. This Order provided that “[i]n no event will the Defense Team disclose, directly or indirectly, Discovery Material or the substance thereof to anyone, including the media (excepting any disclosures that may occur during public proceedings at a hearing, trial, or appeal in connection with this matter), except as provided herein . . . [v]iolations of this Order may be punishable by contempt of court, or by whatever other sanctions the court shall deem just.” *Id.*

The Government brought the Defendant's conduct to the Court's attention as a potential violation of the Defendant's January 2021 Order. *See* Dkt. No. 25 (Gov't Mot. for an Order to Show Cause). After due consideration, the Court warned the Defendant's involvement in similar conduct in the future would result in contempt of court. Dkt. No. 30 (Order Grant. Mot. to Restrict).

Now, for the second time, the Defendant has chosen to violate the Court's January 29, 2021, and February 12, 2021 Orders by giving an interview to a reporter for the television program, "Jugando Pelota Dura," which included numerous statements by the Defendant about this case. These statements were broadcast on June

21, 2022, and transmitted through multiple forums, including television channel “Teleonce” and the social media platform Facebook.<sup>2</sup>

During the program, the reporter specified that Defendant set the time and place of the interview, and that the interview would be broadcast in two sections on June 21 and 22, 2022. During the portions of the interview broadcast on June 21, 2022,<sup>3</sup> the Defendant made a number of statements, including:

- a. a statement in response to the interviewing reporter’s question as to whether he had said that he had information that Raul Maldonado had the chats and for \$300,000.00, the defendant would intercede; the Defendant said that was a total lie and at trial that [lie] would be seen;
- b. statements in response to questions posed by the reporter as to whether La Comay (a puppet used by a well-known political commentator in Puerto Rico, Kobbo Santarosa) would be given \$50,000 to speak favorably about Ricardo Rossello; the defendant stated “didn’t I just tell you that is a lie”;
- c. the Defendant claimed that he could not talk about the case because of a gag order but that the Court’s order could not supplant his dignity and reputation;
- d. the Defendant claimed that in February 2020, he had a contract with Ricardo Rossello and that in October of 2020, he traveled to Los Angeles, California to discuss with lawyers for a famous content distributing company a series of documentaries regarding the summer of 2019, because of that contract with Ricardo Rossello; and

- e. statements by the Defendant that he could not remain silent in light of the lies, politics, and evil of the San Juan Federal Bureau of Investigation.

The context of this interview appears to be in reaction to the Court's Opinion and Order of June 16, 2022. *See* Dkt. No. 127. However, the Defendant's statements are not about information entered without restriction on the docket or disclosed in open court, relating to the facts of the case. In fact, the Defendant's own statements demonstrate his understanding of the restrictions on his communications mandated by the Court's January 29, 2022 Order. Nonetheless, the defendant knowingly and willfully chose to disregard those restrictions and represent clear violations of the Court's two orders in this matter.

The Defendant's statements represent an attempt to influence public opinion and litigate this case in the media through claims that the Government's representatives are liars, politicized, and evil. The Defendant also discussed the involvement of an individual not identified in the Opinion and Order of June 16, 2022. Moreover, the Defendant also discussed an alleged contract with Ricardo Rossello and claimed that certain allegations of the instant matter based on lies. Finally, he acknowledged the Court's January 29, 2021 Order, but qualified its applicability to him.

The Defendant's conduct demonstrates a repeated, willful, and blatant disregard for the Court's authority and the restrictions ordered in this case to protect the integrity of proceedings. The Defendant should be ordered to show cause why the

Court should not hold him in contempt and why his bond not be revoked for a second violation of the Court's January 29 and February 12, 2021 Orders.

WHEREFORE, the Government requests that Defendant be summoned to court for the already scheduled hearing of June 23, 2022, to show cause as to why he should not be held in contempt of court and his bond should not be revoked.
