
## Total estimated federal COVID-19 relief to Puerto Rico



- **\$45 billion** in estimated federal COVID relief/stimulus to Puerto Rico's individuals, businesses and government.
- Total US relief is estimated at \$5.7 trillion
- Relief has come in 3 waves:
  - CARES: \$18.0 billion allocation. Includes 4 phases of federal funding passed March – August 2020. Of this amount, an estimated \$15.2 billion has been disbursed
  - CRRSA: \$7.0 billion allocation passed in December 2020
  - ARP: \$19.9 billion allocation passed in March 2021
- Key relief programs include:
  - Stimulus checks
  - Increased unemployment insurance
  - Small business support (PPP and EIDL loans, etc.)
  - State and local aid
  - COVID-19 testing
  - Education funding

Permitted Uses of State and Local Funds	<ul> <li>To respond to COVID-19 or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality;</li> <li>To respond to workers performing essential work during COVID-19 by providing premium pay to eligible government workers, or by providing grants to eligible employers that have eligible workers;</li> <li>For the provision of government services to the extent of the reduction in revenue of government due to COVID-19 relative to revenues collected in the most recent full fiscal year of the government prior to the emergency; or</li> <li>To make necessary investments in water, sewer, or broadband infrastructure.</li> <li>Incurred by December 31, 2024.</li> </ul>
Prohibited Uses	<ul> <li>Cannot deposit into pension fund.</li> <li>Cannot use funds to offset a reduction in net tax revenue due to change in law, regulation or interpretation made since March 3, 2021. Restriction only applies to State funds.</li> </ul>
Transfer Authority	<ul> <li>Funds may be transferred to a private nonprofit organization, a Tribal organization, a public benefit corporation involved in the transportation of passengers or cargo, or a special-purpose unit of State or local government.</li> </ul>
Timing	<ul> <li>State: within 60 days of certification. Secretary may pay in 2 tranches (2nd tranche 1 year later) based on unemployment rate.</li> <li>Municipalities and counties: 50% within 60 days of ARP, 50% 12 months after ARP</li> </ul>

### **Summary of Funding Categories**

- Business & Individual Tax Incentives: Assistance programs to small and medium businesses. Funds used for losses caused by interruption of operations caused by COVID-19 emergency and / or for necessary expenditures related to COVID-19
- Private Sector Payroll Protection: reimburse private employers, up to 50% of payroll they continued to pay to employees during COVID-19
- Hospitals & Healthcare:
  - Acquisition of Materials and PPE to be distributed in all gov't facilities
  - Emergency Assistance for Public and Private Hospitals: covers necessary expenditures related to COVID-19 emergency
  - Telemedicine Program in PR: ensures the citizens have access to health services with limiting in-person exposure
- COVID-19 Testing and Contact Tracing: funding to continue and expand the contact tracing program to track and isolate people infected with or suspected of being infected with the virus
- UI Benefits: allocation to the Unemployment Trust Fund of the Department of Labor and Human Resources to cover disbursements to people who have applied for state unemployment benefits due to the emergency of COVID-19
- Municipality Expenses: For COVID-19 expenses stated in CARES Act
- **Tourism Industry:** Assistance to hotels and "paradores" for necessary expenditures related to the COVID-19 emergency
- Remote Work Program: Implement the remote or distance work program for Government of Puerto Rico employees
- Emergency Expenses in Prisons: Non-budgeted expenses in prisons
- Homeless Assistance: Covers non-budgeted expenses for assistance and care programs for the homeless population
- **FEMA Cost Share**: Non-Federal Matching Funds Assistance Program for COVID related expenses (this is not for disaster aid response)
- Administrative Expenses: for Administering Puerto Rico's Coronavirus Relief Fund
